OBJECTIVES

Leadership Development

Downtown 100 members are the emerging community leaders. The Downtown 100 provides members opportunities to become better informed about community issues and tools to enhance their leadership skills.

Community Awareness & Involvement

The Downtown 100 sponsors issue-related forums that allow members to meet with city and regional leaders. Downtown 100 members are also provided the opportunity to attend Downtown Norfolk Council events and briefings. These forums and briefings are vehicles that serve to inform and involve members in issues relevant to the Downtown community.

Networking & Volunteerism

The Downtown 100 provides members with both volunteer and networking activities. Social functions provide opportunities for networking and friendship. Volunteer efforts provide a meaningful service to the Downtown community and therefore to the economic health of our region.



Downtown 100 Projects Committee

This year the Projects Committee continued its effort to support the DT100's Signature Project, the Ronald McDonald House Charities of Norfolk. The Ronald McDonald house provides housing for families so they can stay close to their hospitalized child for free. The Norfolk chapter celebrated its 35th anniversary in 2018. Along with the Signature Project, DT100 continues to support the Downtown Norfolk Council and its quest to promote and enhance business, cultural, retail and residential initiatives in Downtown Norfolk.

- Provided over 860 hours of community service to the Downtown Norfolk community. This time is valued at over \$21,750.
- Prepared dinner for families staying at the Ronald McDonald House. Served 50+ family members staying at the Ronald McDonald House over the last 12 months.
- Assisted the Ronald McDonald House with its family room renovation. DT100 cleaned out old décor and furniture. The team also helped Ronald McDonald House list items on Craigslist to create additional funds for the families in need.
- Developed Welcome Packs for families staying at the Ronald McDonald House. DT100 solicited gifts-in-kind and marketing materials from local businesses and attractions for families staying at the Ronald McDonald House.
- Worked with California Pizza Kitchen at MacArthur Center to implement a 6 month give-back campaign to the Ronald McDonald House.
- Partnered with Adopt-A-Student program and provided school supplies and holiday gifts for more than 50 children in need over the last year.
- Provided volunteers for First Fridays. DT100 members helped serve beer and wine.
- Supported NEON District events by volunteering for the NEON Plot Work Days.
- Assisted with the Holidays in the City Grand Illumination Parade and arranged a large DT100 volunteer force.

Downtown 100 Leadership Development Committee

- Maintained an active and engaged committee while expanding leadership opportunities for members of the committee. Pursued alternative venues and methods for building committee camaraderie.
- Hosted a November Forum aboard the Virginia Elite Private Yacht, one of Norfolk's most unique water venues. The forum featured Delegate Jerrauld "Jay" Jones who represents the 89th District for the House of Delegates. As a lifelong Norfolk resident, he strives to make an impact on his community every day. Jay discussed his first year in office, how he is directly affecting our community and ways young professionals can get involved.
- Attended a December Forum at the Hilton Norfolk The Main to discuss downtown development. The half-day program featured keynote speaker Bruce Katz, an urban expert and author of *The New Localism*. Bruce reviewed national trends and explored economic growth opportunities for the region. Following the keynote address, a panel of expert speakers, moderated by Cathy Lewis, focused on areas of business, mobility, residential and retail.
- Hosted a March Forum at ODU's Strome Entrepreneurial Center to discuss Norfolk's thriving athletics scene. The forum featured a panel of guests, moderated by Mike Mars, to discuss the impact athletics have on our community and ways we can improve and retain new talent and sports franchises. The panelists included Will Driscoll, Executive Director of the Virginia Sports Hall of Fame, Wes Hall, Executive Director of the Hampton Roads Sports Commission, and Drew Turner, Associate Athletic Director for Old Dominion University.

- Membership requires that the applicant must live or work in Downtown Norfolk or work for an organization who is a member of the Downtown Norfolk Council.
- Commit to membership of one year to renew by mutual choice on the first day of each calendar year.
- Must be an active member of a committee and annually must attend at least 75% of monthly committee meetings.
- Must attend at least 4 DT100 sponsored events, projects or socials during the calendar year.
- Must attend at least 1 Downtown Norfolk Council meeting or function during the calendar year.
- Must agree to volunteer to support the DT100's projects. A minimum of 10 hours of volunteer support per year is required.

- In the fall held Table for Ten; small group networking events, where each Steering Committee Member organizes a lunch or dinner with a small group of members.
- Continued "New Member Monday", highlighting new members on the Downtown 100 Facebook and Instagram.
- Continued monthly "DT100 Snapshot", information email blasts to all members.
- Held two member breakfast events, encouraging new members to meet and mingle with more seasoned members.
